

## 12.01 PARKS

- (1) DEFINITION. The term "park" is defined to mean playgrounds, recreation fields, buildings, and other areas under the jurisdiction of the park board.
- (2) GENERAL RULES.
  - (a) Night Parking: No cars, campers, person or persons shall be in the park between the hours of 11 p.m. and 7 a.m. excepting for those involving prescheduled activities or special permission by the Park Board.
  - (b) Defacing the Park Property: No person shall cut, break or in any way injure or deface any building, fence, lamp, equipment or facility or any feature of property, including natural objects, upon or within the park.
  - (c) Subject to the additional restrictions set forth below, all pets shall be leashed while in the park and no person shall allow his or her pet to deprive or disrupt the enjoyment or use of any area by others. At no time shall any pet be allowed within 25 feet of any playground equipment located in the park. This subsection does not apply to any seeing eye dog or other animal used to assist the visually handicapped.
  - (d) Littering: No person shall throw, deposit, place or leave in the park therein any paper, rubbish, waste cans, bottles, or refuse of any kind except in receptacles therein provided for waste.
  - (e) Bill Posting: No person shall post, paste, fasten, paint, or affix any placard, bill, notice, sign, or advertising upon any structure or erect any structure for that purpose, unless authorized by the Park Board.
  - (f) Selling Goods: No person shall sell or offer for sale any article or thing whatsoever in any park. This prohibition shall not apply to sales or refreshments and other articles by the Board or under its direction at the stands authorized by the Board.
  - (g) Disturbing the Peace: No threatening, profane, abusive or indecent language, disorderly conduct or behavior shall be allowed in the park.

- (h) Vehicles on the Grass: No person or persons shall drive any motor driven vehicle in the parks except in designated roadway and parking areas.
  - (i) Traffic Rules: No vehicle shall be driven at more than 15 miles per hour on any park road.
  - (j) Fires: It shall be unlawful for any person to start, tend or maintain any fire or to burn any refuse except at designated fireplaces or personal grills. It shall be unlawful for any person to leave any fire unattended.
  - (k) Glass: No glass bottles or containers are allowed east of the park restrooms in the portion of the park known as the ball field area.
- (3) POSTED REGULATIONS. In addition to the regulations herein contained and provided, the Park Board may post, from time to time, specific rules and regulations and such specific rules and regulations when posted by the authority of the Park Board shall be incorporated by reference into this ordinance as fully as if set forth herein.
- (4) POLICE POWERS. Any member of the Calumet County Sheriff Department shall have power to arrest any person or persons who shall be found in violation of the provisions of the ordinance.
- (5) SEPARABILITY. If any sentence, clause or part of the Park Board Code of Ordinances should be adjudged void or of no effect, such decision shall not affect the validity of any other portions.
- (6) PENALTY. Penalty for violation of this Ordinance shall be controlled by Ordinance No. 15.01.
