FROM THE VILLAGE BOARD--

Highlights of the July Board Meeting:

The village board approved the following:

- *Contract modification with Bodart Electric for the ballfield light project. This will allow landscaping to be completed this fall.
- *Permit to MI-Tech to do some underground work in road right-of-way for Time Warner Cable.
- *Operator licenses to Kelly VandeVoort, Michelle Loy and Nichole Fournier.
- *Renewal of the health insurance for the upcoming year with Network Health.
- *Payment request to Bodart Electric in the amount of \$32,500 for the ballfield light project.
- *Approved Resolution 2013-01 regarding the CMAR Report
- *To proceed with plans & specifications for the 2013 street projects as budgeted.
- *To replace the screen on the screening unit at the wastewater treatment plant at a cost of \$6,220.
- *Conditionally approved the CSM for a property split with Paul Gehl on the condition that an easement agreement be recorded to provide access to Outlot #1.

The village board received notification of the following:

- *Notice of receipt of the quarterly street aid payment in the amount of \$12,911.64.
- *Presentation on the Connect Communities Program through the State of Wisconsin.

No unauthorized person shall place, or cause to be placed, any debris of any nature whatsoever, junk, garbage, grass clippings, leaves or any other yard waste or other waste material, other than refuse placed on the terrace for collection, upon the streets, alleys, highways, public parks or other property not owned by him, or upon any body of water within the Village. Any person violating this ordinance shall be required to forfeit \$15.00 plus the cost of removal.
