FROM THE VILLAGE BOARD--

## Highlights of the December Board Meeting:

The village board approved the following:

- \*2017 Lease Agreements for the Welcome to Hilbert Signs.
- \*Resolution 2016\_06 declaring public depositories for 2017.
- \*Resolution 2016\_07 to place funds budgeted for 2016 that will not be expensed before year end to respective reserve funds.
- \*Resolution 2016\_08 to place proceeds from the sale of land to Cozy Baer Storage, LLC into the ballfield fence project.
- \*Resolution 2016\_09 to place proceeds from the sale of land to Lyle Thiel Masonry, LLC into the village hall council room, ( hallway remodel and board room equipment projects.
- \*Appointment of Andy King as the village's attorney for 2017.
- \*Appointment of Shelby Lewis as a new election official for 2017.
- \*Appointment of Jim Schmidt as a CDA committee member.
- \*Operator licenses for Trista Hemauer and Jessica Williams.
- \*The splitting of the village's land on S. 4<sup>th</sup> Street into two separate lots.
- \*Selling of the land on S. 4<sup>th</sup> Street to Lyle Thiel Masonry, LLC.
- \*Request for schooling for Microsoft Office Suite for the deputy clerk.

The village received notice of the following:

- \*Notice of receipt of the 2<sup>nd</sup> installment of shared revenue in the amount of \$333,825.99.
- \*Notice of current year lottery credit in the amount of \$157.95.
- \*Notice of current year first dollar credit in the amount of \$83.99.
- \*Notice of current year state school tax credit in the amount of \$104,475.07 and estimated aid of \$1,236,649.
