From the Village Board – Highlights from the Board Meeting:

The Village Board approved the following:

- To rezone Lots 13 & 14 in Village Meadows Subdivision from R-1, Single Family Residential to R-2, Multi-Family Residential.
- To rezone Parcel No. 13093 at 510 N. 8th St., Parcel No. 13094 at 726 W. Birch St. and Parcel No. 12763 at 209 N. 5th St. from C, Commercial to I, Industrial.
- Change Order #1 (to include the 2020 Project by Sargento Foods) in the 2019 Utility and Street Construction Projects in the amount of \$22,677.
- To approve an updated Citizen Participation Plan for CDBG (Community Development Block Grant) funding and to create a Citizen Participation Plan Committee.
- Resolution 2020-01 to commit funds for prepayment of mortgages for Sunrise I and II apartment buildings on 3rd St. in the approximate amount of \$187,000.
- Operator license for Leah Bechtel.
- The letter of retirement for Charles Fochs; with his last working day being July 8th, 2020.
- The updated job description for the Director of Public Works position.
