From the Village Board – Highlights from the Board Meeting:

The Village Board approved the following:

- The Third Amendment to the Commercial Offer to Purchase regarding the Bel Brands property; which would extend the closing date to March 2021.
- To temporary appoint Tim Keuler as the certified operator at the wastewater treatment plant.
- Application for a Class B license to Two Pair of Dice, LLC and MSIR Entertainment, LLC.
- To repair damage/drainage issues on the lawn by Frontier not to exceed \$1,500.00.
- Resolution 2020-08 TID Affordable Housing Extension Resolution; to extend TID #1 by one additional year.
- Ordinance 2020-02 Amending Section 4.01(2) of the Code of Ordinances in order to incorporate the stop signs in the new subdivision.
- To hire Midwest Parking Lot Maintenance to restripe Main St. in the amount of \$2,238.00.
- To purchase a chain saw and weed eater for the Public Works Dept.
