FROM THE VILLAGE BOARD –

## Highlights of the July Board Meeting:

### The village board approved the following:

- The payment request in the amount of \$172,111.39 to MCC, Inc. for the 2019 Utility & Street Improvements (12<sup>th</sup> St. and 4<sup>th</sup> St. project).
- The request from Allegiant Property Management (management company for the Sunrise Apartment buildings on 3<sup>rd</sup> St.) for forgiveness of the 2019 PILOT (payment in lieu of taxes) in the amount of \$3,000.00.
- The final plat of Fochs Trails Subdivision, 2<sup>nd</sup> Addition.
- Resolution 2019\_07, Preliminary Resolution Declaring Intent to Levy Special Assessments – regarding Fochs Trails Subdivision, 2<sup>nd</sup> Addition.
- Ordinance 2019-02 Amending Chapter 4.08 Golf Carts of the Code of Ordinances.
- Ordinance 2019-03 Amending Chapter 4.09 ATV/UTV of the Code of Ordinances.
- The property split for JJMRS Entertainment, LLC located at 408 N. 8<sup>th</sup> Street.
- To set the public hearing date for August 13, 2019 at 7p.m. regarding the petition to rezone property from Business District to Industrial for the property being split at 408 N. 8<sup>th</sup> Street.
- Updates to the Employee Handbook.
- To increase the employee's share of health insurance premiums from 10.5% to 13%.
- Renewal of the health insurance package for full-time employees for 8/1/19.
- To grant a variance to Sheri Giese, a new resident, in regards to the number of dogs allowed per residence.
- The request to block off Chestnut St. between 7<sup>th</sup> St. and 8<sup>th</sup> St. for the Annual Gospel Fest.
- The request to replace the furnace in the nutrition site room by connecting the room to the current village hall's furnace in the amount of \$2,800.00.
