FROM THE VILLAGE BOARD –

Highlights of the February Board Meeting:

The Village Board approved the following:

- To begin the process for prepayment of the loans for both Sunrise I and Sunrise II Apartments on 3rd Street.
- To contract with Allegiant to lead/assist with the completion of the prepayment process.
- To send 7 members of the Hilbert Fire Department to the WI State Fire Convention in Stevens Point on March 6, 2020.
- To contract with Cedar Corporation for 2020 Economic Consulting Services.
- To proceed with the committee's recommendation for new and replacement sidewalk projects.
- The change order for 2019 Projects to include the 2020 Project by Sargento Foods.
- The Temporary Variance on the number of dogs per residence (from 2 to 4) for a resident until May 1, 2020.

The Village received notice of the following:

- Notice of receipt of PILOT payment for DNR owned land in the amount of \$203.29.
- February settlement for taxes collected to 1/31/20.
