The Village Board approved the following:

- Appointment of Andy King as the Village's attorney for 2021.
- 2021 Lease agreements for the Welcome to Hilbert signs.
- Resolution 2020_10 regarding the reallocation of the Plappert Road Reserve to Village Meadows Reserve.
- Resolution 2020_11 regarding the dedication of the out lots purchased as Thorn Creek Drive.
- Resolution 2020_12 regarding the Declaring Public Depositories for 2021.
- Resolution 2020_13 regarding the placement of 2020 budgeted items not being expensed into respective reserve funds.
- The appointment of Judy Casper as an election inspector.
- The setting of acreage for rental for 2021 for the Village Meadows Subdivision area with no changes from the previous year.
- The contract from Robert E. Lee and Associates, Inc. regarding the 2021 Well Station No. 4 Filter System Engineering Services Proposal.
- To send Mark Fochs to the training regarding cross connection control in April 2021.
