FROM THE VILLAGE BOARD--

Highlights of the August Board Meeting:

The village board approved the following:

- *Temporary Class B Picnic License to the Hilbert Volunteer Fire Department for their End of Summer Celebration at the Community Center/Fire Station on 9/21/13.
- *Purchase of the Galaxy Meter reading system for metering water usage in the village.
- *Award the bid for the 2013 street paving projects to MCC for the amount of \$139,677.93
- *Final payment request for the Main St. water line project to Michels Corp in the amount of \$2,154.30.
- *Change Order #2 for SMA Construction Services for the Well #4 project which resulted in a decrease in the overall contract price of \$13,340.64.
- *Final payment request to SMA Construction Services in the amount of \$27,753.89 for the Well #4 project.
- *Sending Josh McDonald and Charlie Fochs to seminars in Plover on 8/22/13, in Sheboygan on 8/28/13, sending Charlie to the WWOA conference in Stevens Point from 10/22/13 – 10/25/13 and sending Josh to the Intro to Water class in Plover from 10/7/13 – 10/10/13.
- *To allow the fire department to block off 5th St. from Main St. to Cedar St. from 2 p.m. – midnight and to block off Main St. from 4th St. – 6th St. from ½ hr prior to the outdoor mass until ½ hr after the outdoor mass.
- *To allow the Village Hearthstone to block off Main St. from 3rd St. – 4th St. on 9/14/13 for their annual Cruise-In & Dine Car Show.

The village board received notification of the following:

- *Notice from Time Warner Cable that there will be more stations moving from analog format to digital format. It will "channel map" these channels so that they will be visible through the same channel numbers as analog when they are accessed through a TWC supplied digital set top box which will cost \$.99 per month beginning in January 2015.
- *Notice of First Dollar Credit in the amount of \$25,385.08.
- *Notice of receipt of the July installment of shared revenue in the amount of \$64,871.76 and notice of the July School Levy Tax Credit Payment to the county of \$74,466.42.
- *Notice of receipt of the exempt computer aid for real estate in the amount of \$527.00.
- *Notice of receipt of the exempt computer aid for TID #1 of \$203.00 and TID #2 of \$449.00.
- *Notice of preliminary changes in equalized values for the village for 2013. It shows a 3% increase.
- *Notice of preliminary Net New Construction for 2012 & 2013 of 1.53%.
- *Notice of receipt of the quarterly Cable TV Franchise Fees in the amount of \$2,347.99.
