From the Village Board – Highlights from the Regular Board Meeting:

The Village Board approved the following:

- Payment request #1 to Sabel Mechanical in the amount of \$293,684.90 for the sludge dewatering system project at the wastewater treatment facility.
- Resolution 2024-12 regarding the intent to levy special assessments for the 2025 street project for Village Meadows Subdivision and to set the Public Hearing for January 14, 2025 at 5:30 p.m.
- Resolution 2024-13 regarding Declaring Public Depositories for 2025.
- To hire Robert E. Lee to apply for the Urban Forestry Startup Grant in October 2025.
- To allow 2 residents to come up with plans, installation, cost and funding for a possible Civic Park memorial project.
- To increase the rental fee for the Community Center to \$110, the security deposit fee to \$300 and the fundraiser fee/Pitzen room to \$55 effective January 1, 2025 for all new rentals.
- To increase the rental fee for the Civic Park to \$100, the security deposit to \$300 and the fundraiser fee to \$175 effective January 1, 2025 for all new rentals.
- The renewal of McClone Insurance coverage for 2025.
- To appoint Gary Jahn (Menn Law Firm) as the Village attorney for 2025.
- The 2025 lease agreements for the Welcome to Hilbert signs.
- To allow the Village President and the Village Treasurer to pay all bills prior to year end.
- A Christmas bonus for the Village employees.
- The increase in salary for a Village employee.
- The contract with Onward Accounting & Consulting for the filing of the Public Service Commission of WI annual report and Financial Report Form C.
- To fill the vacant village trustee position with Kyle Hunter with her term ending April 2026.

The Village Board received notice of the following:

- The Quarterly Charter Franchise fee payment
- The School Levy Tax Credit and Major State Aids
- The Lottery & Gaming Credit – 2024 Maximum Credit Value
- The First Dollar Credit – 2024 Maximum Credit Value
- The Shared Revenue – November 2024 Distribution
