FROM THE VILLAGE BOARD—  
Highlights of the December Board Meeting:

## The village board approved the following:

- Operator's license for Saraswati Sharma.
- 2018 Lease Agreements for the Welcome to Hilbert Signs.
- Appointment of Andy King as the village's attorney for 2018.
- Resolution 2017\_9 regarding the special assessments for the Highway 114 urbanization project.
- Resolution 2017\_10 declaring public depositories for 2018.
- Resolution 2017\_11 to place funds budgeted for 2017 that will not be expensed before year end to respective reserve funds.
- The village insurance renewal for 2018.
- Payment request in the amount of \$6,528.20 to MCC, Inc for the 2017 paving projects.
- To hire Cedar Corporation as the consultant for the Village Wide Development Plan.
- The recommendation to rent the village's 50 acres of land on the southside of the village to Schneider Farms for 2018.
- The revision of the employee handbook pertaining to schooling/training and sick days.
- Approved an incentive pay scale for full-time public works employees.

## The village received notice of the following:

- Notice of the receipt of the 2<sup>nd</sup> installment of shared revenue in the amount of \$333,685.13.
- Notice of current year lottery credit in the amount of \$149.17.
- Notice of current year first dollar credit in the amount of \$85.24.
- Notice of current year state school tax credit in the amount of \$119,793.86 and estimated aid of \$1,239,714.00.
- Notice of receipt of the quarterly cable tv franchise fees in the amount of \$2,301.16.

## HYDRANTS AND SNOW

With the snowy season now here, we are asking residents to keep hydrants clear of snow so that the connections can be accessed. We are asking that you please keep about 6" to 8" of snow packed around the base of the hydrant.
