FROM THE VILLAGE BOARD--

Highlights of the September Board Meeting:

The village board approved the following:

- *Operator license for Christopher Billingsley
- *Amended engineering contract with Robert E. Lee for the wastewater treatment plant upgrades.
- *Financial consultant contracts with Ehlers for the treatment plant upgrades and the interceptor main project.
- *Bond counsel contracts with Miller, McGinn & Clark for the treatment plant upgrades and the interceptor main project.
- *Resolution 2014-05 to appoint an authorized representative to submit grant applications and do reports for the recycling grants.
- *Resolution 2014-06 to amend the 2014 budget to place funds not expended for fire department equipment into a reserve fund for the purpose of painting the walls and doing electrical work in the fire station.
- *Resolution 2014-07 to replace Resolution 2014-01 declaring the village's intent to reimburse for expenditures in connection with the treatment plant upgrades. This had to be revised to incorporate an increase in the overall costs due to additions and changes to the upgrade plans.
- *Change Orders #1 & #2 to MCC for the 2014 paving projects.
- *Payment request to MCC in the amount of \$116,041.76 for the 2014 paving projects.
- *To allow the fire department to proceed with painting of the walls in the fire station and that the park and recreation committee will get prices on the electrical work to be completed.
- *To allow Charlie to attend the WWOA conference in Green Bay in October.
- *To allow the Village Hearthstone to block off Main St. from 3rd St. to the railroad tracks from 2 p.m. – 10 p.m. for their Annual Cruise-In & Dine Car Show.
- *To complete the 10 year inspection on Well #2 with CTW Corporation.
- *To allow the school district to hold a bonfire as part of their homecoming festivities on September 25th.
- *Accepted the resignation of Joshua Jetton as a public works employee.
