FROM THE VILLAGE BOARD--

Highlights of the October Board Meeting:

The village board approved the following:

- *Approved allowing Dennis DuPrey to attend the District 6 Clerk's meeting in Manitowoc on 10/24/13.
- *Approved a 3 year contract for auditing services with Schenck Associates.
- *Approved Resolution 2013-02 to Support the Consolidation Recycling Efficiency Grant.
- *Approve the submittal of the 2014 recycling grant application.
- *Approved the temporary Class B License to the Hilbert/Potter Optimist Group for their annual Bingo Bash on 11/23/13.

The village board received notification of the following:

- *Notice of Freedom from Workplace Bullies Week which will be October 20th – October 26th.
- *Notice of receipt of the quarterly street aid payment in the amount of \$12,911.64.
- *Notice of revised estimated 2nd installment of shared revenue in the amount of \$334,932.
- *Notice of estimated 2014 street aid in the amount of \$51,846.29.
- *Notice of estimated 2014 shared revenue in the amount of \$398,826.
- *Notice from the City of Chilton that they are not interested in our group expanding into the city for first responder coverage.

2014 Budget

The village's proposed general fund budget for 2014 includes expenses totaling \$1,006,737 which is a decrease over the 2013 budget of \$1,073,421. The 2013 budget included the outlay for new ballfield lights. Even though expenses are dropping by this amount, the total levy is proposed to be \$391,154.37 which also includes the two TIF Districts. This is an increase of \$19,183.60 over last year which will increase our local tax rate to \$6.84 compared to 6.56 or an increase of \$.28 or 4.25% when compared to last year. The public hearing on the proposed budgets is scheduled for 7 p.m. on Tuesday, November 12, 2013 at the village hall located at 26 N. 6th St. If you wish to have a copy of the full budget documents, please contact the clerk's office and we will gladly provide one.
