## Highlights of the March Board Meeting:

The village board approved the following:

- The request from the Hilbert Revitalization Group to hold the annual Cheesehead Run on Saturday, August 18<sup>th</sup>.
- To place a temporary closure of the road between the two ballfields for the upcoming season.
- The request from the Hilbert High School business class to place ADA Radius Plates with advertising in the intersections along Main Street at no cost to the village.
- The application for Class B Liquor & Beer License to 22 Reasons, LLC conditionally based upon satisfying the 15 day waiting period.
- The addition of the Personal Appearance/Dress Code policy to the Employee Handbook.
- The request to replace the chop saw.
- The request of repairing the slide on the playground equipment at Civic Park.
- The request to continue with the wall system for sludge storage building at the waste water treatment plant as budgeted.
- The request to replace the lawnmower that is used at the waste water treatment plant.
- To upgrade the electrical at the park which includes donations from the and the Hilbert Lions Club and Voices of Peace.
