From the Village Board – Highlights from the Board Meeting:

**The Village Board approved the following:**

- Ordinance 2020-01, regarding signs in Business and Industrial Districts, stating that roof signs shall not be permitted in any District.
- Application for 6-month class B license for the Hilbert Athletic Association.
- Application for Temporary Class B license for the Hilbert Lions Club for the Community 4<sup>th</sup> of July Picnic.
- Appointment of Board Standing Committees and other annual appointments.
- To renew the Crop Land Lease for the WWTP land to Schneider Farms, Inc.
- The request to forgive current year PILOT (payment in lieu of taxes) payment for Sunrise I and Sunrise II.
- The Fire Department's request regarding replacing the SCBA's, in order to be in compliance, for the amount of \$94,270.00.

**The Village received notice of the following:**

- Notice of Receipt of Personal Property Aid (Real Estate) in the amount of \$3,161.62.
- Notice of Receipt of Personal Property Aid (TIF Districts) in the amount of \$4,451.09.
