## Highlights of the November Board Meeting:

### The village board approved the following:

- Operator's license for Josh Diedrich.
- Adding Ortho and Vision coverage to the employee insurance benefits.
- Ordinance 2018\_03 regarding fire inspections to be completed one time per year instead of two times.
- The Civic Park Concept Plan prepared by East Central Wisconsin Regional Planning Commission; which can be used as a guide to follow regarding future plans with Civic Park. This plan will also make the village eligible for certain grant funds.
- The village board at their special board meeting held at 6 p.m. approved the following:
  1. The Offer to Purchase to purchase a strip of land approximately 20' x 250' from Society of St. Vincent Depaul for \$10,000 and a strip of land approximately 46' x 250' from Frontier North, Inc. for \$14,700. This area will be dedicated as street right of way to provide the village with an additional access point into the 50 acres purchased last year for future residential development.
  2. The Offer to Purchase to purchase the Bel Brands USA property near the Hilbert Civic Park for \$89,900. The plan for the village is that this property would be redeveloped.
  3. A contract with Cedar Corporation to conduct a full Phase 1 assessment on the Bel Brands USA property at a cost of \$2,500.

### The village received notice of the following:

- Notice of limit to qualify for a 2020 Expenditure Restraint Payment.

## 2019 BUDGET

The village held their public hearing and approved the 2019 budgets for all funds. The total expenditures for 2019 are \$1,220,357.00 compared to \$1,286,818.00 last year. The village tax rate will be \$7.8375236 compared to \$7.9401787 last year. This budget includes funding to begin implementation of the village wide development plan and continues funding to continue using Cedar Corporation for a development consultant.
